Guidelines:

- 1.) Property must be in Deschutes, Jefferson, Crook or Harney counties.
- 2.) Must have been completed between 10/1/16 and 10/1/2018.
- 3.) Have significant impact on, or enhancement to the community through economic impact, neighborhood/community improvement, neighborhood/community beautification, unique design, unique use of materials.
- 4.) Can be new construction and/or renovation/restoration.
- 5.) Individuals and small corporations will be given priority over large corporation or government projects.
- 6.) After nomination the property will be reviewed and toured. Approximately 10 properties will be chosen in July.

The award ceremony will take place October 10th. This event is attended by awardees, COAR members and the public. Those that nominated a project that meets all the criteria will received 2 tickets to the event. Each winner receives 4 tickets to the event.
